## A Firm With a Legacy of Legal Excellence


It is a Gulfport-based law firm that has been around for over 27 years. The senior partners have over 70 years of combined legal experience. Yet, longevity tells only part of the story of Owen, Galloway & Myers. It is also a story of community heritage.

The two founding partners—Joe Sam Owen and Ben Galloway—have deep ties to the Mississippi Coast. They graduated two years apart from Gulfport High School. Since the formation of the firm, Owen has been involved in many complex civil and criminal matters throughout the state.

Owen and Galloway graduated from the University of Mississippi Law School, and by 1982 joined forces in a firm with rich roots in the community. With offices on 25th Ave. in the Gulfport business district, Owen says, "My dad grew up just five blocks north of my office."

The Mississippi Coast connections continue with partner Robert Myers Jr. from Pascagoula. The firm's community ties go beyond legal matters. Owen is active in community and church affairs, has helped build ball fields and is a long-time volunteer high school baseball coach.

Owen's work ethic and aggressive defense of the case proved productive. Warr received probation on one count.

The firm also helped Katrina victims, handling over 300 cases of hurricanerelated insurance disputes for individuals and businesses dealing with structure and personal property claims and claims for loss of income.

Owen thinks knowing the community's heritage and needs, and having decades-old ties to the community, can be key in reaching settlements.

"We have satisfactorily resolved 95 percent of the Katrina cases," Owen says. "Our reputation and past litigation success help to resolve cases. We have the respect of both sides of the bar and our fair-minded approach to settlement has proved beneficial. We are able to effect settlements that benefit both parties."
